

Ginger Group acquires German HPC Group, a leading European player in Environmental Engineering

Elancourt, France - On 26th March 2025, Ginger Group, the French leader in independent and committed engineering, acquired HPC AG, headquartered in Harburg (Swabia), Germany, a major player in environmental engineering with a presence in several European countries. With the integration of a group of more than 800 employees and a turnover of more than 100 million euros, Ginger's turnover will soon exceed 500 million euros, consolidating its position as a European leader in environmental and infrastructure engineering.

Founded in 1948, HPC is one of Europe's leading environmental engineering companies. It operates in nine European countries and has a leading position in Germany and Italy. HPC relies on a network of 50 local offices to be close to its clients, which include industrial companies, public authorities and infrastructure operators.

HPC offers a wide range of services in the areas of land recycling, environmental consulting and infrastructure planning including geotechnical and civil engineering, urban water and ground water management, renewable energy as well as sustainability.

This expansion ensures its presence in the three largest markets in the European Union.
